ABOUT US

The congregation of St. Theresa of Lisieux (CST) has been involved in various socio-economic, educational and health care activities since the very inception of the society in 1931.

A vast stretch of land over 50 acres forms the campus with its scenic beauty. The Lisieux College of Nursing is a Christian minority educational institution established, maintained and administered by the MAGJ hospital Trust the College of Nursing with an annual in-take of 50 students for B.Sc. Nursing was established in the year 2022-2023. The college is recognized by the Indian Nursing Council (I.N.C.) as well as the Kerala Nursing and Midwifery Council and is affiliated to the Kerala University of Health Sciences KUHS. Our parent hospital is a NABH accredited 300 bedded (working bed 200) multi-specialty hospital with various department functioning with all advanced technologies.

CAMPUS FACILITIES

The 3.25-acre campus has excellent infrastructure and learning resources that collectively provide a stimulating and enjoyable learning ambiance. The hostels accommodate over 300girls. Student amenities are within the campus, viz indoor and outdoor stadia, auditorium, garden, prayer places, co-operative store, books shop, canteens, etc. The Health Insurance Scheme is also available to the students. The institution also focuses towards a holistic health approach. There is an excellent yoga center within the campus.

SMART CLASSROOM

Classrooms are designed for accommodating 60 students which fulfills the guideline given by the regulatory bodies. Every class room is provided with ergonomically designed seating arrangements, smart board, sound system, Wi-Fi connectivity and CCTV cameras and storage facilities.

LABORATORY FACILITIES

The institution has well equipped laboratory facilities for foundations of nursing, community health nursing, nutrition, preclinical, and computer.

LIBRARY

The library set-up consists of 2800sq.ft, with reading room facilities with wide range of books ,E-Resources ,national and international journals for students and faculty.

TRANSPORT FACILITY

The institute has a bus for the transportation, as well as the other campus buses facilities are also available for the students and staff.

The institution provides both indoor and outdoor sports facilities

HOSTEL

A well-furnished hostel facility is provided within the campus for both boys and girls. The hostel facilities include canteen, and indoor & outdoor sports and other recreational facilities.

NRI CATEGORY SEATS

Academic Year 2024-25 – Instructions to the Applicants

- 1. Applications for admission to first year B.Sc. Nursing (Academic year 2024-2025) in the 08 NRI category seats at this college is being invited on the basis of this prospectus.
- 2. Academic Eligibility: To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed 10 + 2 examination with cut-off limit of 85% or above of marks set for NRI category, for example 85% and above marks under the Kerala State Higher Secondary Board (Kerala HSC) OR Central Board of Secondary Education (CBSE) OR Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).

Note: All applicants must have taken courses in **Biology, Physics and Chemistry** in addition to English in the High School Years (during their 10th, 11th and 12th). They should have secured at least 85%marks in Biology, Physics and Chemistry at the Plus Two level. Wherever alphabetical grades like A, B-, C+, etc. are used by the school; appropriate equivalence in terms of percentage like 90%, and 85% should be made available.

Only students from high schools accredited by the respective State or the country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and **Equivalency Certificate** to this effect shall be produced.

- 3. **Age Requirements:** Applicants must be at least 17 years of age on 31st December 2024 (the date of birth being shown on the Matriculation or equivalent certificate).
- 4. Eligibility for admission to NRI. Category Seats: according to the GO (MS) No. 243/2014/ H&FWD dated 06.08.2014, "An Applicant who depends upon his / her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife Brothers and Sisters (inclusive of first cousins) of Father or Mother/Half Brother/Half Sister/Adopted Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.
- 5. Copy of the following documents duly attested by a Gazette Officer to prove the NRI status shall be submitted:
 - Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.

- ii. Copy of the relevant pages of the passport containing visa details that is attested by the Embassy.
- iii. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.
- iv.A self-affidavit / declaration (**find specimen format in Annexure-1**) by the NRI relative (Sponsorship Certificate).
- 5. Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate &the NRI relative as per G O(MS)No.243/2014/ H & FWD dated 06.08.2014.
- 6. **FEE STRUCTURE**: A selected applicant in NRI category is liable to pay the following fees:

Note: Apart from the schedule of fees given above, the students will be required to pay the proportionate administration / affiliation / examination fee, etc. payable to the University from time to time .Hostel & Mess fee will be charged separately.

7. Scheme of Admission:

- i. Application Form can be downloaded from the college website from 02nd July 2024 onwards.

- iii. The last date for the submission of the application form will be **4:00 pm, on 20**th **July 2024.** The application form should be completed carefully; furnishing the entire information called for.
- iv.Attested Photocopies of the following documents shall be attached with the downloaded copy of the Application (The originals documents will have to be submitted at the time of admission).

- a) School Leaving Certificate (SSLC) of student establishing that the student has completed 17 years of age as on 31-12-2024.
- b) HSCE or equivalent examination mark-sheet/pass certificate.
- c) Proof for NRI status (**Refr. no. 5 above**).
- d) A statement to show that the high school in which the student has studied has been accredited by the State / Country / University (if applicable).
- e) Equivalence Certificate from Association of Indian Universities (if applicable).
- f) Eligibility certificate from Kerala University of Health Sciences (if applicable).
- 7. As per the regulations of the University and the Regulatory Council, admissions will have to be closed by 30-09-2024 of the year of admission. After closure of admissions, the seat, if vacant, cannot be filled up. Such seats will go vacant for the entire duration of the course. Therefore, those who leave the course after the closure of admissions will have to pay liquidated damages equivalent to the tuition fees for the remaining period of the course. Any complaints in this regard shall be subject to the legal and factual scrutiny and the decision of the ASC/FRC. The colleges shall return the Certificate and TC of these students, on execution of a bond by the student along with any of his/her Parents, undertaking to pay the amount that may be ordered by the ASC/FRC or the Court of Law.
- 8. All students who get selected should get themselves vaccinated against Hepatitis before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
- 9. Every student is required to adhere strictly to the Code of Conduct of the college.
- 10. Ragging is strictly prohibited. If it is found during the admission or any time there after that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the principal shall report the matter to the civil/police authorities.
- 11. Without prejudice to the directions of the Nursing Councils/Government/University, the decision of Congregation of St. Therese of Lisieux (CST Brothers) shall be final on all matters with regard to admission.
